

**UNIFORM MISDEMEANOR BAIL
SCHEDULE**

LAKE COUNTY SUPERIOR COURT

ADOPTED

November 17, 2010

Pursuant to the provisions of PC § 1269b(c), the following uniform County wide bail schedule for misdemeanor offenses is hereby adopted. This schedule sets bail amounts for the release of prisoners arrested without a warrant on misdemeanor charges.

All misdemeanors not listed herein shall be \$1,000, except the crimes for Traffic, Forestry, Fish & Game, Boating, and miscellaneous scheduled crimes attached. Those offenses should be in the amount on the statewide schedules.

If the amount of bail specified in this bail schedule is different then the amount on the statewide schedule, the amount specified in this bail schedule shall prevail

All “wobblers” charged as misdemeanors shall be in the amount of \$5,000.

Any offense alleging a prior conviction shall be in the standard amount plus \$1,000 for each prior.
