

**LAKE COUNTY SUPERIOR COURT**  
**UNIFORM BAIL SCHEDULE**

Pursuant to the provisions of Penal Code § 1269b, subdivision (c), the following uniform countywide schedule of bail for all bailable felony offenses and for all misdemeanor offenses is hereby adopted. This schedule sets bail for the release of prisoners arrested without a warrant on bailable felony charges and on all misdemeanor charges.

**The burden is on a peace officer to request an order setting a higher bail if the scheduled bail is inadequate. In that event, a peace officer shall prepare a declaration under penalty of perjury setting forth the facts and circumstances in support of his or her belief and file it with the magistrate. See Penal Code §1269c.**

For any felony charge, not listed on this schedule, the bail shall be:


<u>Aggravated Term for Offense</u>	<u>Bail</u>
3 years	\$15,000
4 years	\$20,000
5 years	\$25,000
6 years	\$30,000
7 years	\$35,000
8 or more years	\$50,000
All life sentences	\$1,000,000


If a prisoner has been arrested on more than one felony charge or on a felony and a misdemeanor charge, the bail for the most serious felony charge shall be used. If a prisoner has been arrested on more than one misdemeanor charge, the bail for the most serious misdemeanor charge shall be used.


If there are felony charges for different dates, the bail amounts for the most serious charge for each date are added together. If there are felony charges involving more than one victim, the bail amounts for the most serious charge for each victim are added together. For example: 459 1<sup>st</sup> degree on May 9 on victim A, 459 1<sup>st</sup> degree on May 16 on victim B, 594 on May 16 on victim B and 496 on May 16 on Victim C= \$50,000 + \$50,000 + \$15,000 = \$115,000 total bail.

Enhancements are prison terms added to the sentence because of the way the crime was committed or because of the status of the defendant. For each enhancing factor relating to the most serious felony offense chargeable in the complaint, additional bail shall be required in the amounts shown on the attached Schedule of Bail Enhancing Factors (page 8). There is no limit on adding amounts for enhancements. For any enhancement which is not listed the bail amount is \$25,000.
