Calendars in purple text will be conducted by Zoom.

\*\*These calendars will be conducted by Zoom when possible. However, out of custody defendants are required to appear in person unless they have a 977 waiver.

Civil and Family contested hearings may be direct set Thursdays or Fridays, but not Wednesdays due to potential for jury trials.

Ideal calendar sizes are listed next to the in-person calendars. For criminal calendars, it is number of defendants, not number of cases.
